Guidance on entries

They should focus on dialogue rather than narration.

Examples of appropriate themes...

- The inversion or parody of conventional wisdom
- the absurdity of abstract thinking separated from action
- the stupidity of closing oneself off from the people one is interacting with
- the heroism of persisting even in hopeless causes
- the danger of too much self-obsession, including self-reproach for sins

Rules of Entry

- 1. This competition is open to all, is international and welcomes non-UK entries.

- 3. Entries must not exceed 350 words. The Fable title and name of entrant are not included in that limit.
- 4. Entries must be submitted in an email to mrrls.fable@yahoo.com with the email title being the name of the Fable. The name of the entrant must be at the foot of the email. The Fable can be accepted as a pdf or MS WORD attachment.
- 5. Entries should be in a plain legible form. A sans 14pt font is suggested.
- 6. Participants are free to enter multiple times.
- 7. Entry is free. The competition will be open from 13 November 2021 to 2 April 2022. Any entries outside of these dates will not be considered.
- 8. All entries must be the exclusive and original work of the entrant. Any entrant under the age of 16 at the closing submission date of 2 April 2022 must have permission from their parent or guardian, to whom any prize will be paid on the entrant's behalf.
